The Authority on Advance Ruling (AAR), Karnataka ascertain whether the leased property qualifies as has ruled that GST is applicable on residential a "residential dwelling" to claim the exemption accommodation sublet by tenant, a ruling that benefit. experts said could open a Pandora's box of litigations.

In a case involving about 42 single rooms having been sublet by a tenant to students for a period ranging between three months to 11 months, AAR noted that the property given out for sub-renting matched that of a hotel-rooms with attached termed as a residential dwelling", or a house.

While renting of accommodation is exempted from goods and services tax(GST), the authority has ruled, "the exemption prescribed cannot be sought and be lessors have to charge GST while issuing invoice for the lease services". It said,"the applicant is not providing the services of leasing in individual capacity to the company but as a part of the group of lessors. It is seen from the agreement that lessors are providing the service of leasing or renting of immovable property for a consideration".

The AAR order dated March 23 is likely to Trigger a number of litigations, experts said. "With this ruling, lessors may not have the comfort of presuming GST to be exempt, where end use of the property is residential, "said Harpreet Singh partner at KPMG India. One would need to

On the basis of the ruling, tax authorities could well begin demanding 18% GST applicable on renting out commercial property from the landowner leasing residential hostel-style accommodation to school, colleges, educational institutions, offices, corporates, or any other establishment. "Though Ruling has some basic logic to it, still it is expected bathrooms "which can by no imagination be to open a Pandora's box of litigations for numerous individuals earning passive income," said Rajat Mohan, senior partner at AMRG Associates.

<u>Incentives under Income Tax</u> for Cashless Economy

payments and expenditure working as an incentive to build a cashless economy.

(A) Cash transaction limit reduced to Rs.10000/under section 40A(3A):

Existing threshold limit of cash payment to person Rs.20000/- reduced to Rs. 10000/- in a single day. Provided that payments otherwise than by an account payee cheque/bank draft or use of ECS through a bank account, means cash payment above Rs 10,000 to a person in a day, shall not be allowed as deduction in computing business income.

(B) Cash transaction for capital expenditure more than Rs.10000/- No Depreciation U/s 43 and No Deduction U/s 35AD

acquisition of any asset in respect which a payment or aggregate of payments made to a person in a day, otherwise than by an account payee cheque drawn on a bank or account payee bank draft or ECS through a bank account, exceeds Rs.10000/-, such expenditure shall be ignored for the purposes of determination of actual cost of such asset and no depreciation shall be allowed To discourage cash transactions and push digital on same u/s 43.

Similarly, such expenditure is not eligible for deduction in respect of expenditure incurred on setting up of a Specified Business u/s 35AD.





(D) Cash receipt restricted to 3 lakh rupees u/s 269ST & 271D :

let us discuss sections relating to discouraging cash No person, except the Government, any banking company, post office savings bank or co-operative bank shall receive in cash, an amount of 3 lakh rupees or more, from a person in a day, in respect of a single transaction for a single event or occasion.

> Section 271DA imposes a 100% penalty on a person who receives a sum in contravention of the new Section 269ST. Means penalty will be equivalent to the amount of such receipt.

(E) Restriction on Cash Donation u/s 80G:

No deduction shall be allowed in respect of donation of amount exceeding of 2000 rupees paid in Cash.

(F) Transparency in Electoral Funding : Section 13A
